Proceedings of the 2nd meeting of District Level Sanctioning Committee (DLSC), Uttar Dinajpur held on 22nd February at 3.00 pm in the Collectorate Building, Uttar Dinajpur regarding implementation of Farm Mechanization Scheme, 2021-22.

The District Magistrate & Collector, Uttar Dinajpur District and Chairman, DLSC (Farm Mechanization Scheme) took the chair and presided over the meeting.

- 1) Initially the Deputy Director of Agriculture (Administration), Uttar Dinajpur district apprised the members about the continuation and progress of Farm Mechanization Scheme during 2021-22 and also intimated that the some allocation (1st allotment) have already been received for the district for all three components of Farm Mechanization scheme. After deliberations as stated below, the following resolutions are adopted by the DLSC-FM, Uttar Dinajpur in this meeting.
- 2) In 1st DLSC-FM meeting, 100 nos of beneficiaries from each block (maximum) have been accorded sanction. But as per communication received from the blocks, many of the beneficiaries in the approved list (first 100 nos of beneficiaries of BLSC approved lists) have not turned up to purchase the machineries applied for within due date. Hence Asst. DAs of blocks have asked for according permission to some more applicants under OTA-SFI and FSSM by DLSC, so as to utilize fund received/to be received promptly within time limit. Hence, up to 200 more applications as per list sanctioned by BLSC of each block have been accorded approval today for both OTA-SFI, and FSSM scheme components per block.

3) Custom Hiring Centres:

(a) In principle approvals have been accorded to 25 persons after getting feasibility report from blocks and sub-division end. After further scrutiny, 16 (sixteen) nos. of applications have been found to be OK (as per prescribed guidelines/norms) and all of them submitted loan sanction letter from respective/desired banks. Hence these applications may be accorded Sanction by DLSC. (Annexure-I)

Among these applicants, the sum total of the costs of machineries for and Sri Anil Chandra Debnath (Sl No 13) and Sri Jiyaul Haque (Sl no 14) contain calculation error (As per application sum totals are Rs 2607851/- and Rs 3006685/- respectively). The actual sum total for these two cases would be Rs 2488167/- and Rs 3116102/- respectively. The sanctions have been accorded by DLSC for actual sum total for these two cases.

(b) Among 25 applications given in principle sanctions, on further scrutiny, it is found that there are some deviations from the prescribed norms in TFO (Total Financial Outlay) amount and/or numbers and types of machineries chosen by the respective applicants in 6 cases. As the application process in purely portal based, and the concerned portal has been locked after prescribed date of submitting applications, the applicants or the implementing offices are not in a position to correct the same. The Bank Loan Sanction Letters have already been received for 5 nos of such cases (Except Sl No -5). More ever, DLSC further approves two cases with such type of anomalies (vide serial no 7 and 8 in Annexure-II) for inclusion in beneficiary list. The DLSC asked the Deputy Director of

Agriculture (Administration), Uttar Dinajpur to bring the matter to the notice of the higher authority, as this error have occurred due to information gap regarding the scheme. If higher/competent authority accorded permission for correction, then these applications may be further processed. All these (8) eight applications have been accorded sanction by DLSC today, but further processing will be done if allowed for correction by higher/competent authority. (Annexure-II)

- (c) Out of the 25 applications given in principle approval, 3 applicants have not yet submitted Loan Sanction letter from the banks. Hence, DLSC accorded sanction to these three applicants on condition that the applicants should submit Loan Sanction letter from banks shortly to the office of the Deputy Director of Agriculture (Administration), Uttar Dinajpur (Annexure-III).
- (d) As 11 (eleven) nos. of applications (Item b and c) already given in principle approval, are not yet ready for further processing, new 5 (five) nos. of cases have been accorded final sanction by this DLSC for initiating processing of the same and providing subsidy if adequate fund is made available in due course in this financial year. (Annexure-IV)
