**Sub:- Approval of Names of Eligible Beneficiaries for Credit linked Subsidy Scheme for Rural Entrepreneur to set up Custom Hiring Centre of Farm Machinery under Farm Mechanization Schemes during 2021-22.**

Vide Notification No. 998-AG/P./2S(Inputs)--03/2012 (Pt.-I) dtd. the 17<sup>th</sup> August, 2021 (copy attached) of the Agril. Deptt., Govt. of West Bengal, the **continuation order of Farm Mechanisation Schemes for 2021-22** had been circulated. As per Guideline of the Farm Mechanisation schemes, following steps may be followed to setup **Custom Hiring Centre of Farm Machinery** during 2021-22 with the following objectives:-

A. To offset high cost of owning Farm Machinery for small holdings. For Machineries of CHC to be hired out to all farmers, with preference accorded to small & marginal farmers of the adjoining areas .  
B. Individual Farmer/Entrepreneur is eligible to set up CHC with project cost (TFO) upto 40 Lakh and the Commercial organised sectors or Groups are eligible to set up CHC with project cost (TFO) between 20 Lakh to 250 Lakh.

C. The Maximum subsidy limited to 40% of Total Financial Outlay(TFO). All CHC will be established under the model of back ended financial Assistance

D. The Banks will sanction Loan to eligible entrepreneur upto a maximum of 75% of the of TFO.

The DDA(Admn.) will place the subsidy in the Subsidy Reserve Fund/Loan Account in the Bank.

Now, on receiving the applications along with Eligibility Report on setting up of CHC from Assistant Director of Agriculture(Admn.), of Uluberia Sub-Division & Assistant Director of Agriculture(Blocks) concerned., **The list of eligible entrepreneur is cited below-**


