Sub: DLSC approval of Farm Mechanization schemes viz-FSSM & OTA-SFI during 2021-22.

In continuation to the memo no.998-AG/P/2S (Inputs)-03/2012 Pt-(I) dated Howrah 17th August,2021 of Special Secretary, Govt. of West Bengal,(Flag-'A') Financial Support Scheme for Farm Mechanization (FSSM) & One Time Assistance to Small & Marginal Farmers for purchase of Small Farm Implements (OTA-SFI) 2021-22 are being implemented to this district. Online applications through Matirkatha portal were received from 04.11.2021 to 18.11.2021. Total 4147 nos. of online applications under FSSM & 3325 nos. of application under OTA-SFI were received by the 15 blocks of Malda district. After verification & scrutiny, Block Level Screening committee (BLSC) recommended 3673 nos. of FSSM applications out of 4147 & 3027 nos. of OTA application out of 3325. Total application rejected FSSM-478 & OTA-SFI-300.
